Maksi, Madhya Pradesh, November 16, 2025: In a landmark moment for India's renewable energy sector, Hon'ble Chief Minister of Madhya Pradesh, **Dr. Mohan Yadav**, laid the foundation stone (Bhoomi Poojan) for Jakson Group's first phase of 6 GW Integrated Solar Ingot, Wafer, Cell, and Module Manufacturing Facility at Maksi Phase II, Ujjain District.

In Phase-I, Jakson will establish a 3 GW solar cell and 4 GW solar module manufacturing facility, followed by backward integration into ingot and wafer production in subsequent phases. The project will also help develop a robust solar manufacturing ecosystem in Madhya Pradesh, fostering supply chain and ancillary industry growth.

Jakson Group already has a strong presence in the state with a 150 KLPD grain-based ethanol manufacturing plant in Balaghat. The upcoming solar manufacturing facility further strengthens this partnership with the state and underscores Jakson's long-term commitment to advancing India's clean energy and self-reliance goals.
